OVERVIEW

They directed all aspects of litigation, coordinated investigations with experts across multiple disciplines, managed local counsel, and provided strategic legal and indemnification analysis to clients.

He was responsible for developing defense and resolution strategies, overseeing client reporting, and ensuring compliance with client billing guidelines.
